Item 1: Questions

1. How are the bidders to account for the 83 days of anticipated rain / weather days per year identified in the contract as non-compensable and unallowable delays within the construction schedule?

Answer: AISD is currently reviewing an Adverse Weather Guideline that will replace previous Special Provisions in the current agreement. The approved Adverse Weather Guideline will be shared with the selected proposers. For purposes of establishing project duration in your proposal, reference the following published links. Should a proposer deviate from these durations, clarify the assumptions by which your proposed duration is based.

- Is Subguard allowed as an alternate subcontractor security?
 Answer: Please reference Section 6.1.6 of the Agreement and Section 10 of the GCC.
- 3. When in the process will the substantial completion dates be established for each project?

Answer: Substantial Completion is established upon execution of the agreement (refer to Section 11.4 of the Agreement).

For purposes of establishing project duration in your proposal, the Substantial Completion Date should be set at a minimum of 60 days prior to the established opening date.

- 8. The RFP indicates that our general conditions personnel costs are based on the duration from start to substantial completion. How do we pay the salaries for the remaining two months between substantial completion and final completion? What category of costs should these be included?
 - The proposed Maximum Project General Conditions amount should consider necessary costs from Substantial Completion to Final Completion. Please refer to Section 8.3.A in the GCC to reference expectations related to Substantial Completion and requirements thereafter.
- 9. What is the bond rate (Item 5 on the Proposed Pricing Schedule) based upon? Percentage of Cost of Work or percentage of Total Contract Amount? This refers to the Payment and Performance Bond Rate. Please review Section 10.10.B in the GCC to understand when and how this policy should be calculated.

 - Comprehensive Summary Schedule states Precon start 4-1-19, then extends for 12 months
 - Comprehensive Detailed Schedule shows Precon start 7-1-19, then extends for 9 months.
