<p>6:10 p.m.</p>	<p>Community Communications</p> <p>Sgt Angelica Covington – working with Health Services to promote Fentanyl awareness. Used the 1st time on a parent 2 weeks ago; parent was arrested. 2nd case -suspected student overdose but Narcan was not needed/used. SRO's are prepared to educate students on campuses. Will work with Health Services as a team, wants to provide clear communication; has the law enforcement on her side.</p> <p>Chelsie Eades – Community Member – Member of Travis County Overdose Endeavor. She wants to help with Fentanyl campaign; has been studying for years. Wants to be a SHAC member and wants to see curriculum. Asked about budget for Narcan. Sober coaches, silver mentorship. Who will be teaching lessons? Students should hear from someone closer to their age; students will not listen to teachers. Is Fentanyl illegal? Are we receiving any \$\$ from Perdue Pharma?</p> <p>Martha Bull – member of Travis County Overdose Endeavor. Created a campaign and wants to distribute information to high school students. <p>6:11 p.m.</p>	<p>Health Service Update</p> <p>Shout out to Sgt. Covington and SROs for increasing awareness. Health Services will be going to the Board meeting tomorrow night for approval on Narcan. We have received Narcan doses for free. Ready to start distributing once approved by Board. Kids are 80% more enlightened, thanks to the AISD police. HS will help and work with PD.</p> <p>Dr. Edwards – asked Addison if she’s seen anything on her campus. Addison said she’s not seen or heard anything about Fentanyl, she attends LASA.</p> <p>Question: Is City of Austin PD carrying Narcan? Sgt Covington was unsure. Jose confirmed as of 2021, Austin PD does carry Narcan.</p> <p>Alana – Narcan will start out in the AED’s nearest to the nurse’s office. Asking admin on campuses along with Quick care staff to take the Narcan trainings. Police will have Narcan, High Schools and Middle Schools will have multiple doses.</p> <p>Alana – reports showing a heavy flu season this year. Every campus is offering a flu clinic. Central Office will offer Flu and Covid.</p> <p>Belynda: Community Care has a mobile truck on Akins campus to offer testing.</p> <p>Jose and Donna participated in a local community coalition call to discuss Flu data; will meet again next month.</p> <p>Nick – do we have availability of flu testing on sites? Alana said not in the campus health rooms. Testing will be available at community sites, not campuses. Dr. Edwards: Asked Board of items to discuss

Alana Bejarano: reached out to leadership about outdoor lunches. It is the principal's purview that they choose for their own campus. Could not get a good count of who is currently eating outside. SHAC can send the benefits of outdoor lunch and outdoor learning to principals.

Dr. Gallas: every grade in ES is having PE every day. Seems that each school decides their own schedule.

Gena McKinley: her student is getting less PE than prior. More rules, overworked PE teacher. Maybe we can evaluate and send our recommendations. Principal calling her for support knowing that she is on the SHAC.

Stephanie Hebert: Pat Werner & Kelly Page are visiting campuses daily to see PE classes. Each campus is choosing their own schedule. Staffing and space issues are being documented as they try to support teachers. They are also talking about it with Chief Casas. Ask principals to talk to Pat Werner if they have any concerns.

Dr. Edwards asked Stephanie: What metrics - # in the gym, # of staff, how are they allocating staff (inside & out), looking at instruction, what tech are they using, safety concerns? Asked for those metrics to be shared at the next SHAC meeting.

Dr. Edwards will send the Outdoor letter sent last year to all SHAC members. We can ask the Board to share with the principals.

Stephanie Hebert: update on Sex education Curriculum.

- 1st year rolling out K-12th grade. Asking a lot of all our campuses.
- They are doing Trainer of Trainers at each Elementary school teachers for 2 campus staff at each campus. Several campuses held their trainings on last Friday's Professional Development. Will also happen on 11.8.22.
- Trainings being held for Secondary MS Science and HS Health teachers via Zoom
- Permissions will go out 3 weeks before the sessions.
- Principals will also hold parent meetings prior.
- Met with SPED this week. Currently working on a toolkit with specific visual and auditory accommodations needed.

Susanna Kearns (SHAC member question via email – she was unable to attend SHAC meeting):

Alana Bejarano: In 2021 – House Bill was passed that TX Schools will pass out DNA kits to every enrolled student in the event that a student's body needs to be identified if they are a victim of a crime.

Alana has reached out to TEA for info. Parents can turn in the DNA samples either to us or the police dept. or choose not to do the samples. Alana will provide update as soon as she
